MINUTES

April 14, 2020

Mayor Smith called the meeting to order at 7:01 p.m. Present were mayor Smith; council members Grove, Lewis, Ueckert & Stanzel who participated electronically, city attorney Andrea Griffin, city clerk Suhr.

Mayor Smith noted the location of the open meetings act, & stated one copy of all reproducible written material to be discussed at this meeting is available for examination or copying.

Council member Lewis led the Pledge of Allegiance.

Proof of publication was on the council desk.

Visitors & Correspondence –The Mayor invited anyone present who wished to address an agenda item & is not on the agenda to come forward at this time, noting they will have 3 minutes to speak.

Grove moved to approve the agenda. Ueckert seconded. All in favor, motion carried.

Council consideration of rezoning request that was denied by the Planning Commission – Council members asked why the application was denied & what options were considered. Mayor Smith has talked to Keith Marvin regarding updating the future land use map & comprehensive plan. Michael Burns stated the Planning Commission decision was based on the possibility of future residential housing in that area.

Jim Nachreiner, JMN Construction stated his case for having the property rezoned

Bob Hampton, Flatwater Developer stated his reasons for not rezoning the property.

Discussion followed regarding mining permit, homeowners don't want commercial and rezoning now & in the future.

Ueckert moved to rezone the property to commercial & to rezone back to residential in the future. The motion died for lack of a second.

Ueckert moved to rezone the property to C-3 Highway Business. Grove seconded. All in favor, motion carried.

Council member Grove moved to suspend the rules for consideration of Ordinance No.736 entitled: AN ORDINANCE AMENDING THE ZONING REGULATIONS OF VALLEY, DOUGLAS COUNTY, NEBRASKA; FINDING THE PROPOSED AMENDMENT WAS DULY SUBMITTED TO THE PLANNING BOARD OF VALLEY, DOUGLAS COUNTY, NEBRASKA, FOR ITS RECOMMENDATION AND THAT IT RECOMMENDED THE ADOPTION OF THE

AMENDMENT FINDING THAT NOTICE OF HEARING ON SUCH AMENDMENT WAS DULY GIVEN PRIOR TO THE HEARING AS PROVIDED BY LAW AND THAT SUCH PUBLIC HEARING WAS HAD THEREON FINDING THAT THE ZONING MAP OF VALLEY, DOUGLAS COUNTY, NEBRASKA BE AMENDED AS FOLLOWS: THAT THE DESCRIBED REAL PROPERTY BE REZONED FROM R-2, MEDIUML/HIGH DENSITY RESIDENTAL TO TA, TRANSISTIONAL AGRICULTURAL. Schulte Addition, Lot 1 Block 0 Ex S 17 Ft – Irreg 1.94 Acres. Stanzel seconded the motion. All in favor, motion carried.

Council member Grove moved for final passage. Ueckert seconded. All in favor, motion carried. A true, correct & complete copy is on file at city hall.

Council member Ueckert moved to suspend the rules for consideration of Ordinance No.737 entitled: AN ORDINANCE TO AMEND AN EXISTING SECTION OF THE CITY OF VALLEY MUNICIPAL CODE RELATING TO THE CONTROL OF EXCESSIVE NOISE, PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE; PROVIDING FOR A SEVERABILITY CLAUSE, AND PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH. Grove seconded. All in favor, motion carried.

Council member Ueckert moved for final passage. Grove seconded. Ueckert, Grove & Stanzel voted YES. Lewis voted NO, motion carried. A true, correct & complete copy is on file at city hall.

Council member Lewis introduced, read & moved for passage of Resolution No. 2020-13, to authorize Mayor Smith to execute an agreement with Twin Rivers YMCA to operate the outdoor pool for the 2020 season. Grove seconded. All in favor, motion carried. A true, correct & complete copy is on file at city hall.

Item 13. Council consideration & action to close North Pine Street between Front Street & the alley for a fundraiser. The event has been cancelled.

Chief Smith reported the number of false alarm calls between January 1, 2019 & February 29, 2020. Discussion about billing, collection of fines, enforcement and service disruptions followed. Council consensus was to table action pending more information.

City Attorney – Council members had received the memorandum from the city attorney that ouitlined the provisions of the Flatwater 2 & 3 subdivision & the letter of irrevocable credit agreements.

Grove introduced, read & moved for passage of Resolution No. 2020-15 authorizing Mayor Smith to execute the subdivision agreement & the irrevocable letter of credit agreement for Flatwater 2 & 3. Ueckert seconded. All in favor, motion carried. A true, correct complete copy is on file at city hall.

City Engineer - a. Flatwater improvements Phase 1 Update. Greg Perry reported the lift station is operational & pumping. The manhole cover is scheduled to be completed tomorrow.

b. Flatwater Improvements Phase 2 Rebid (Sanitary Sewer and Water Main) Council members reviewed the bids received. Mr. Perry recommended the bid be awarded to Vrba Construction. Grove moved to award the project for Flatwater Phase 2 sanitary sewer & water main to Vrba Construction, \$1,523,369.50. All in favor, motion carried.

c. Flatwater Improvements Phase 2 (paving) – following review of the bids that were received in January 2020, Mr. Perry recommended the contract be awarded to Steve Harris Construction, Inc.

Lewis moved to award the Flatwater Phase 2 paving project to Steve Harris Construction, Inc. \$502,093.60. Ueckert seconded. All in favor, motion carried.

d. Flatwater Improvements Phase 3 (Paving) – the bids received January 2020 were reviewed and Mr. Perry recommended the contract be awarded to Steve Harris Construction, Inc.

Grove moved to award the Flatwater Phase 3 paving project to Steve Harris Comstruction, Inc, \$362,417.48. Ueckert seconded. All in favor, motion carried.

e. 2019 Flood Recovery Gardiner Street Pumping Station – Jim Olmsted reported the project is 40% complete. He recommended approval of Judds Brothers Co., pay request 3,

Grove introduced, read & moved for approval of Judds Brothers Construction Company pay request No. 3, \$95,310.00. Lewis seconded. All in favor, motion carried. A true, correct & complete copy is on file at city hall.

- f. Other Updates / Miscellaneous 1. 2019 Flood Recovery Valmont Lift Station Rehab Update Mr. Olmsted reported he & PeopleService are working with two companies to get prices.
- 2. Front Street Pavement Reconstruction July start date for the project.
- 3. 2019 Flood Recovery Ball Field Restoration Project. The contracts are signed & work will begin in two weeks.
- 4. Timber Shores SID Drainage Project. Greg Perry will continue to monitor the project.
- 5. Country Aire 2 May 4th is the scheduled date for utility work to begin.
- 6. Elkhorn Athletic Association (EAA) project. There has been no activity on this project.
- 7. Quasar Drive In Theater Sewer Service Agreement. The attorneys are working on agreements.

Mayor's Report – Planning Commission Zoom / Call in Meeting is April 21 – 4:30 P.M., Valley Days Zoom / Call in meeting, nothing in person, is April 21 - 6 P.M., Arbor Day Tree Planting – April 23 - 2 p.m. – in the Arboretum, Valley Clean Up Day is Saturday May 2 from 9 to 2, Twin Rivers "Y" Dinner & Auction is postponed to a later date; Valley Shores Assessments – Received \$2,133.09 with February property taxes – leaving a balance of \$56,586., Officer Strudl has resigned effective April 20. Chief Smith is filling in with part time officers until Robby Coffey is deployed, Work on the last piece of ditch along Highway 64 (Ida Street) was completed last week, Public Works have used a couple loads of material patching potholes & are also doing concrete repair & replacement, Received notice from FEMA the Pines culvert intersection replacement funding has been approved for payment, Valley has been assigned a new FEMA rep, Joe Kezar, Valhaven Administrator reported there no Covid 19 cases at Valhaven, There also are none at Valley Lakes (Orchard Gardens). Both facilities continue to maintain lockdown procedures. Rise Broadband plans to install a 1" dish on the water tower in the near future. Council approved the installation at the March 2019 meeting.
